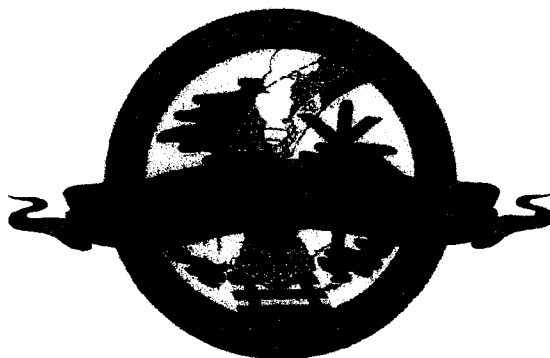

TO WHOM IT MAY CONCERN

Re: Carver Companies Water District Extension/Service Matter
Hamlet of Coeymans, Town of Coeymans, Albany County, NY

The Village has been made aware of the request by Carver Companies for the extension of Water District Number One located in the Hamlet of Coeymans, Town of Coeymans, Albany County, New York, to include service to the Applicant's property up to what is known as "the conveyor belt" on NYS Route 144 located in said Hamlet. Additionally, the Village has a written correspondence request for an extension of water service for approximately four hundred feet (400') northerly of said "conveyor belt" to provide treated water to the proposed General Electric Wind Mill Project. The Village is willing to favorably consider the request of the Applicant, with the following conditions to be observed relative to the same.

The conditions are nonnegotiable and are as follows:


- The meter to be installed in connection with said project shall be read quarterly (four times) each year by the Village Water Department for the appropriate billing.
- All water provided to the above-requested area, including any other locations of Carver Companies, such as in the Industrial Park, et al., shall be billed at the current industrial rate as established by the Village.

- A main line of a minimum of eight inches (8") will need to be installed as part of the infrastructure for any water service to be provided to the north of "the conveyor belt" area, all at the expense of the Applicant herein, subject to the inspection by the Village. The main line shall also include fire protection to the buildings to be constructed on said site.
- Access to the meter and inspection of the property for compliance with all water regulations of the Village of Ravenna shall be allowed by the Applicant to the appropriate official of the Village of Ravenna Water Department upon some reasonable notice given to the Applicant dependent upon the purpose for the inspection.
- A limit of the gallonage to be used per day without the installation of a storage tank/tower shall be set by the Village's Engineer, Barton & Loguidice. In the event that the Applicant exceeds said acceptable limit of daily gallonage, the appropriate storage tank/tower shall be installed promptly by the Applicant pursuant to the evaluation provided by said Engineers.
- A resolution shall be passed by the Village of Ravenna Board to accept the current service district up to and including the area south of "the conveyor belt" area, as well as the extension to the north of the same as described hereinabove.
- The Applicant shall assist the Village in procuring a Nine Million Dollar (\$9,000,000.00) grant so as to increase the capacity of their water filtration plant and system in anticipation of the needs of the Applicant herein.


We trust that this correspondence will serve the purposes for which it was requested.


